# SSA-190839: X\_T File Parsing Vulnerabilities in Parasolid

### SUMMARY

Parasolid is affected by out of bounds write vulnerabilities that could be triggered when the application reads files in X\_T format. If a user is tricked to open a malicious file with the affected applications, an attacker could leverage the vulnerability to perform remote code execution in the context of the current process.

Siemens has released updates for the affected products and recommends to update to the latest versions.

# PRODUCT DESCRIPTION

Parasolid is a 3D geometric modeling tool that supports various techniques, including solid modeling, direct editing, and free-form surface/sheet modeling.

#### VULNERABILITY CLASSIFICATION

The vulnerability classification has been performed by using the CVSS scoring system in version 3.1 (CVSS v3.1) (https://www.first.org/cvss/). The CVSS environmental score is specific to the customer's environment and will impact the overall CVSS score. The environmental score should therefore be individually defined by the customer to accomplish final scoring.

An additional classification has been performed using the CWE classification, a community-developed list of common software security weaknesses. This serves as a common language and as a baseline for weakness identification, mitigation, and prevention efforts. A detailed list of CWE classes can be found at: https://cwe.mitre.org/.

#### Vulnerability CVE-2023-41032

The affected application contains an out of bounds write past the end of an allocated structure while parsing specially crafted X\_T files. This could allow an attacker to execute code in the context of the current process. (ZDI-CAN-21263)
